5. Change to the IACS Constitution

G. Centi presented the motivations for the changes that were distributed in advance to the members of the IACS Council

CONSTITUTION Article 3. Membership of the Council

(a) The Council shall be composed of duly accredited delegates of member countries or groups of countries. Each member country or member group of countries shall have two delegates. The Council decides by secret ballot on the admission of new member countries or groups of countries,

and the removal of the names of countries that either no longer exist as states represented in IUPAC or no longer fulfil the conditions for admission. A minimum condition for membership is that scientists working in that country, or group of countries, have contributed several papers to recent International Congresses on Catalysis. Admission or removal of a member requires a three-fourths (3/4) majority vote of the Council. Membership of a group of countries excludes each country of that group from direct membership, unless the Council decides on a new definition of the remaining

group. Before each Council meeting, the Secretary provides all Council members with a list of the countries and groups of countries that are members of the Council; this list also states explicitly which countries form part of a member group and which countries, if any, have changed their official names since the previous Council meeting. After approval by the Council, this list will be attached to the minutes of the Council meeting.

- (b) Appointment of delegates will be made by a national or multinational organisation, competent in the field of catalysis. Problems concerning the appointment of delegates to the Council or the selection of the organisations that make these appointments will be submitted to IUPAC for resolution.
- (c) The normal term of office of delegates shall be from the beginning of one ICC to the beginning of the next. If new appointments are made by a national or multinational organisation, competent in the field of catalysis, between two ICCs, the term of office ends with the beginning of the next IACS Councils.

REVISED Article 3. Meetings

(a) The Council shall be composed of up to two duly accredited delegates of the catalysis association representing regions, countries or groups of . Each catalysis association member of IACS has the right to one vote. The Council decides by secret ballot on the admission of new member associations and the removal of those no longer fulfil the conditions for admission. A minimum condition for membership is that scientists working in that region, country, or group of countries, have contributed several papers to recent International Congresses on Catalysis. Admission or removal of a member requires a three-fourths (3/4) majority vote of the Council. Membership of a group of countries excludes each country of that group from direct

membership, unless the Council decides on a new definition of the remaining group.

- (b) Delegates will be appointed by a regional, national, or multinational organisation competent in catalysis.
- (c) The normal term of office of delegates shall be from the beginning of one ICC to the beginning of the next. If new appointments are made by a regional, national or multinational organisation, competent in the field of catalysis, between two ICCs, the term of office ends with the beginning of the next IACS Councils.

REVISED Article 9. Meetings

(a) The Council shall meet at the time of each ICC. In the case of justified motivations, approved by the majority of the council via electronic vote, specific decisions may be taken electronically or via an online meeting. The meeting at each ICC may be in a hybrid form (in person with also participation online) to allow a large attendance. The business of the Council ...

The Officers of the Council constitute the Executive Committee. They may nominate up to two additional members at large. The main functions....

6. Election of the new IACS Executive Committee

According to the Constitution, "The Council at each ICC shall elect by secret ballot a Vice-President, Secretary, Treasurer and a representative chosen from the delegates of the Council. The Vice-President becomes President after the next ICC."

During the past mandate, the vice-President, Prof. Enrique Iglesia, resigned, and according to the Constitution ("On the event of loss of both the President and Vice-President, the Executive Committee shall designate a temporary executive officer until the meeting of the next Council meeting") a new vice-President was nominated by the Executive Committee (David Farrusseng). Due to this special situation, the Executive Board has decided to vote also the position of the President. The Executive Board will make a proposal. New candidatures are welcome up to the end of June 2024. The vote will be by a secret ballot. A specific case is the Treasurer. Our IACS account is in the UK, and the Treasurer must be from the UK.

To be held in Kyoto from 25 to 30 June, 2028 at Kyoto International Conference Center (Towards a Brilliant Future).

The bid was presented by Japanese organizers who replied to questions raised by the Council.

iii) Thailand

Approved by unanimous decision

iv) Taiwan.

G. Centi introduced the case and said that the approved changes to the Constitution open the possibility of overcoming the questions raised by P.R. China.

After extensive discussion, the Council has decided that the changes in the Constitution have solved the issues raised by China, and Taiwan has the characteristics required to be admitted as a new member of IACS. However, there still exists the need for an agreement between PR China and Taiwan about the name to adopt for the latter. This should be defined by a common discussion between PR China and Taiwan delegates ASAP. Then, the formal decision will be made by electronic vote within one year from ICC18.
