1:42 pm President Repor on the IACS Legal framework: an Update and Path Forward (Item 4). IACS retained lawyer, Stefano Vannuzzi, joined this part of the discussion.

Situation report:

In the last Council Meeting (July 14th 2024), the council has decided to explore different banking options. We also wanted to take this opportunity to explore banking options (e.g. outside of UK) for flexibility and tax motivations. In the meantime, we realised that the IACS convention do not comply with current laws/bank regulations. IACS board of directors appointed a lawyer, Stefano VANNUZZI, for a situation report and path forward. We have explored multiple paths and feasibility to operate IACS globally (North America, Europe, Asia, etc.) with executive board members from multiple continents.

Proposal:

IACS to move from a defacto association to a non-profit association with a legal status; to be able to execute our missions more effectively in a legalized framework and be protected.

We propose to follows the way EFCATS has recently taken.

New convention will, fulfill legal issues for non-profit organisations, allow smoother transition of the board of directors, keep the same objectives/content We will start with

•Member enrollment: (i) legal associations: by signature, (ii) for de facto national/regional associations: by adoption.

a. 22 voted yes, 0 abstain

The timeline towards legalization is: Spring 2025 (first draft), Fall 2025 (set up legal association via a General Assembly), Fall 2025-Winter 2026 (transfer of bank account), Summer 2026 (Fully operational)
